- Speakers should register either 1). by emailing the commission or 2). by signing up in-person at the meeting itself in order to be recognized by the Chair.
 - 1). To register, send an email to centercommission@seattle.gov with “public comment” in the subject line **before 10:00 am on Thursday, November 7, 2024.**
 - 2). Alternatively, sign up to speak on the public comment sign-up sheet located inside the meeting room at least 15 minutes prior to each Seattle Center Advisory Commission meeting.
- Each speaker may be allotted up to two minutes to speak.
- In addition to topics on the agenda, the Chair may allow public comment on other topics.
- If you are unable to attend the meeting in-person or remotely, please submit written comments to centercommission@seattle.gov



DIRECTIONS TO ARMORY LOFT 3 (3rd Floor, Balcony Level):

- **Enter the Armory on the Main Floor (2nd Floor, Food Atrium Level).**
- **You will see large center staircase, next to the stage. Ascend these stairs.**
- **At the top of the stairs, proceed straight through the glass doors.**
- **Once inside the doors, turn right down the hallway.**
- **Armory Loft 3 is the first door on your right.**

If you need further directions, visit Customer Service located next to the center staircase on the Main Floor (2nd Floor, Food Atrium Level). Contact them at 206-684-7200.

NOTES:

If you need an elevator, it is located on the Main Floor (2nd Floor, Food Atrium Level), in front of Wing Dome restaurant. Take elevator to the Balcony Level (3rd Floor). Take a right around the balcony and continue until you see restrooms on your left along with glass doors. Proceed straight through glass doors and once inside, turn right down the hallway. Armory Loft 3 is the first door on your left.

If you enter the Armory from the north side, where the eagle statues are located, ascend the steps, take the hallway on your right and you will find an elevator on your immediate left. Take the elevator up to the 3rd Floor Armory Loft Lobby area, exit to your right and continue down the hallway. Armory Loft 3 is the first door on your left.
